2. Course Description

This course comprehensively explores the cornerstone statistical and mathematical methods used in economics to analyze data. It focuses on the theoretical foundations of various statistical methods and estimators, as well as their practical applications to specific examples. Additionally, it evaluates different methods to determine their suitability under different settings.

The primary objectives of the course are two-fold: First, to prepare students for further empirical work in economics or other social sciences. Second, to teach students data analysis. By the end of this class, students will have gained a solid understanding of statistical analysis and can apply their knowledge to real-world scenarios.

3. Required Materials

The textbook for this class is "Introduction to Econometrics" by James Stock and Mark Watson (SW), 4th edition, Addison-Wesley.

4. Software

The software used in this class is Stata (version 17 or later), which is available for free to all Georgetown students.

To download Stata: go to http://georgetown.onthehub.com/WebStore/Welcome.aspx, sign up and enter "Stata." You can select the version compatible with your computer.

5. Assignments, Requirements and Grading Criteria

Homework Assignments:

Regular problem sets will be posted, and answer keys will be provided. Many of the exercises will come from the SW book, and they can be either theoretical or practical.

There will be three assignments. Each homework will be graded out of 10 and equally weighted in the final assignment grade. Submissions are only accepted on Canvas. Late submissions will **not be allowed** except under exceptional circumstances.

Assignments are crucial study aids and require timely and independent effort to master the material. The problem sets are indicative of midterm and final exams, so it is important to ensure you understand and can solve problems independently. Form study groups to discuss problems; however, assignments must be submitted individually.

• Exams:

There will be a midterm and a final. The midterm is on July 24th, and the final exam is on August 7th. Note that the exam dates may be subject to change. Material covered in midterm will be everything up to that point; the final exam will cover the whole course material.
