THEO 3835: Courage, Hope, Justice

COURSE DESCRIPTION

How do we become courageous but not reckless? Maintain hope in a world full of despair? This course addresses the virtues of courage, hope, and justice and its religious, psychological, and social dimensions. We will explore physical, moral, and spiritual courage, hope, and justice through the lives of individuals in the community, such as Colin Kaepernick, and in the face of climate change. We will look at how courage and hope manifest in everyday life and in addiction and financial stress. Attention will be given to how religious practices sustain courage, hope, and justice. While there is an emphasis on Christian ethics, discussions, and applications are not limited to Christian approaches. The course is designed so that students can put their own faith tradition or humanist worldview in conversation with course material. **The summer version of this course does *not* have a Community-Based Learning component.** Credits: 3

1. Discussion Boards and Personal Reflection (35%)

You will participate in five discussion board activities, the lowest grade will be dropped. Some require a series of two posts (your post and your response). Grades will be based on accurate content, reflection, thoroughness, spelling, grammar, and timely submission. There will also be periodic optional discussion boards. You will complete one personal reflection.

2. Learning Engagement Activities, Minor Assignments (8%)

This includes the quality and timeliness of VoiceThread comments and other indicators of engagement. You may skip one VoiceThread comments without negatively impacting your grade. You may also be invited to make optional VoiceThread Comments. There will be two optional synchronous meetings for students. These will be scheduled at a time that meets your schedule and can make up for one missed VT comment.

3. Quizzes (2) (13.5% each/27%)

You have two cumulative quizzes during the course.

- 4. **Exemplar Project (10%)** research, and contribute a 4-6 minute Voice Thread presentation focused on a person, social actor, or organization you admire
- 5. **Final Paper (20%)** Write a final paper of a full 5-7 pages: Character Trait or Virtue(s) in Relation to Self's Flourishing / Vocation, and Character Trait or Virtue(s) in Relation to Social Justice/Injustice.

Assignment Completion: Written work is due by the assigned due date on Canvas. Submit your assignments online by the time assigned in Canvas; DO NOT SEND YOUR PAPERS TO OTHER PERSONAL OR PROFESSIONAL EMAIL ADDRESSES. Discussion posts and class participation are contingent on the timely submission of your responses.

Late Work Submission Policy: Discussion board posts made after the comments due date will receive a maximum grade of a C. Most discussion boards have two parts; complete both by the respective deadlines for full credit. Quizzes cannot be taken late. Plan accordingly. Reflections and papers will receive grade penalties for late submissions.

Our online classes are designed to meet the same academic standards as our place-based (face-to-face) courses. You can think of each module as equal to the same level of participation, commitment, and academic rigor as a face-to-face class. Students should plan on spending approximately 10-12 hours per week on the work for each online module.

COMMUNICATION EXPECTATIONS

Communication with Peers and with Professor

You will be expected to engage with your peers via VoiceThread and discussions on a regular basis.

- Check your writing. Proofread (i.e. grammar and spelling) your message before sending.
- **Do not use AI.** Unless you have been given explicit permission by the instructor to do so.

The Georgetown University Honor System defines plagiarism as "the act of passing off as one's own the ideas or writings of another." More guidance is available through the <u>Gervase Programs</u>. If you have any doubts about plagiarism, paraphrasing, and the need for credit, check out <u>Plagiarism.org</u>.

All submissions must be your original work. Using artificial intelligence, without explicit instructor permission, is considered a violation of the honor policy.

Any submission suspected of plagiarism will be immediately referred to the Honor Council for investigation and possible adjudication. All students are expected to follow Georgetown's honor code unconditionally. If you have not done so, please read the honor code material located online at the <u>Honor Council website</u>.

SEXUAL MISCONDUCT
